Vide paper read as (1) above, an application for affiliation of a Pharmacy College was received from the General Secretary, Ezhuthachan National Academy, Marayamuttom, Neyyattinkara, Thiruvananthapuram for the academic year 2003-04.

Vide paper read as (2) above, the Syndicate at its meeting held on 30/5/2003 considered the application for affiliation of the college for the academic year 2003-04 in the light of the reports of the Inspection Commission and decided to issue NOC to the Ezhuthachan National Academy, Marayamuttom, Neyyattinkara, Thiruvananthapuram for starting a Pharmacy College at Marayamuttom during the academic year 2003-04.

The AICTE, vide paper read as (3) above, accorded approval to the Ezhuthachan National Academy, Marayamuttom, Neyyattinkara, Thiruvananthapuram for the establishment of Ezhuthachan National Academy Pharmacy College, Marayamuttom, Neyyattinkara, Thiruvananthapuram for the academic year 2003-04 to conduct the B.Pharmacy Degree Course with an annual intake of 60 students.

The Government of Kerala vide G.O. read as (4) above, accorded sanction for effecting admission to the B.Pharm Degree Course in Ezhuthachan National Academy, Marayamuttom, Neyyattinkara, Thiruvananthapuram for the academic year 2003-04.

Vide paper read as (5) above, the Syndicate at its meeting held on 25/1/2005 considered the Minutes of the Sub-committee convened for considering the question of affiliation of the Pharmacy College by Ezhuthachan National Academy, Marayamuttom and recommended that provisional affiliation be granted to the Pharmacy College by the Ezhuthachan National Academy, Marayamuttom, Neyyattinkara, Thiruvananthapuram for the academic year 2003-04.



Vide paper read as (6) above, the General Secretary, Ezhuthachan National Academy was informed of the decision of the Syndicate with a direction to fulfil the formalities for granting provisional affiliation to the college.

Vide paper read as (7) and (8), the General Secretary, Ezhuthachan National Academy, Marayamuttom, Neyyattinkara, Thiruvananthapuram has fulfilled the prescribed formalities for obtaining provisional affiliation by executing the prescribed Agreement and Letter of Undertaking.

In the circumstances, Provisional Affiliation is granted to the Ezhuthachan National Academy Pharmacy College, Marayamuttom, Neyyattinkara, Thiruvananthapuram for the academic year 2003-04, to function on a self-financing basis for the conduct of the B.Pharm Degree Course having a duration of 4 (four) years with an annual intake of 60 (sixty) students, subject to the condition that there will not be any financial commitment on the part of the Government or the University.

The Provisional Affiliation granted is subject to the provisions in the Kerala University Act, 1974, and the Statutes made thereunder.
