Vide paper read (1) above, the University has invited applications for continuation of provisional affiliation for the academic year 2011-12 to colleges/courses affiliated to this University.

As per paper read (2) above the Principal, Ezhuthachan College of Pharmaceutical Sciences, Marayamuttom, Neyyattinkara, Thiruvananthapuram has applied for continuation of provisional affiliation to B.Pharm course in their institution for the year 2011-12.

On verification of the application read as (3) above, it is found eligible to grant continuation of provisional affiliation to conduct B.Pharm course in the college as they have remitted necessary fees and have obtained permission from the Central/State Council for the academic year 2011-12.

Sanction has therefore been accorded by the Vice Chancellor by exercising his powers under Section 12(7) of Kerala University of Health Sciences Act, 2010 to grant continuation of provisional affiliation to Ezhuthachan College of Pharmaceutical Sciences, Marayamuttom, Neyyattinkara, Thiruvananthapuram to conduct B.Pharm. course with 60 seats during the academic year 2011-12 subject to the conditions mentioned below:

1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University and on the basis of the direction issued by the University from time to time, failing to which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. The College should remit annual administration fee of Rs. 1250 per student for the academic year 2011-12 within 10 days from the closure of admission.
4. Affiliation granted is strictly provisional and only for the academic year 2011-12. The college has to apply for continuation of affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
5. Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
