**Order**

Vide paper read (1) above, the General Secretary, Ezhuthachan National Academy, Neyyattinkara has applied for affiliation to M.Pharm Pharmaceutical Chemistry course with 18 seats in Ezhuthachan College of Pharmaceutical Sciences for the academic 2011-12.

The applications were processed by the University and the inspection commission of the University has recommended for starting the courses in the college.

As per paper read (2) above All India Council for Technical Education has granted approval to conduct the courses in the college during the academic year 2012-13. Vide paper referred (3) above, the High Court of Kerala has directed the University to consider the matter of granting affiliation without insisting on the NOC from the State Government.

The College has remitted Rs. 50000/(Rs.Fifty thousand only) towards fees for affiliation to the courses.

Considering the above, sanction has been accorded by the the Vice Chancellor by exercising his powers under Section 12(7) of Kerala University of Health Sciences Act, 2010 to grant provisional affiliation to M.Pharm Pharmaceutical Chemistry course with 18 seats in Ezhuthachan College of Pharmaceutical Sciences, Marayamuttaom, Neyyattinkara for the academic year 2012-13 subject to the following conditions;

- a. The Government has informed that they are filing a SLP against the

Hon'ble High Court judgement. Provisional affiliation is granted subject to the outcome of SLP.

- b. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University and on the basis of the direction issued by the University from time to time, failing to which the affiliation granted will automatically be cancelled.
- c. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- d. The College should remit annual administration fee of Rs Rs.2000/ per student for this academic year .
- e. Affiliation granted is strictly provisional and only for the academic year 2012-13. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- f. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- g. The Management should collect fees from the students as follows:
