ORDER

As per paper read (1) above, applications were invited for continuation of provisional affiliation for the academic year 2018-19 from colleges for courses affiliated to the University. The Principal, Ezhuthachan College Of Pharmaceutical Sciences, Thiruvananthapuram-MP007, vide paper read (2) above has submitted applications for the Continuation of Provisional affiliation for the year 2018-19

2. Pursuant to the application,vide paper read (3) above an inspection commission was constituted.The Scrutiny Committee vide papers read (4) & (7) above pointed out some deficiencies. These deficiencies were intimated to the college vide papers read (5) & (8) above. The college vide papers read (6) & (9) above has furnished compliance report. After scrutiny of the compliance report, the Scrutiny Committee vide paper read (10) above recommended to grant Continuation of Provisional Affiliation to the college for the year 2018-19.

3. 47th Governing Council vide paper read(11) above decided to grant Continuation of Provisional Affiliation to Ezhuthachan College Of Pharmaceutical Sciences, Thiruvananthapuram for the academic year 2018-19 on receipt of approval orders from AICTE & PCI .



4. Ezhuthachan College Of Pharmaceutical Sciences, Thiruvananthapuram vide papers read (12) & (13) has submitted approval orders from PCI & AICTE for the academic year 2018-19.

5. Sanction, has therefore been accorded by the Vice-Chancellor by implementing the decision of Governing Council read (11) above to grant Continuation of Provisional Affiliation to Ezhuthachan College Of Pharmaceutical Sciences, Thiruvananthapuram-MP007 for conducting the following courses with an annual intake of students mentioned against each during the academic year 2018-19 subject to the conditions detailed below:-


- 1 i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 ii. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 iii. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 iv. The College should remit annual administration fee fixed for UG/PG course for the academic year 2018-19
- 5 v. Admission to the next academic year shall be made only after obtaining prior permission from the University.
