- 1) They should obtain formal orders from the University concerned regarding affiliation before the course is started.

- 2) 50% of seats should be filled up by the candidates advised by the Commissioner of Entrance Examinations of Government of Kerala, and the remaining 50% of seats from the list prepared by the management of the Institution.


