Sir/Madam

With reference to the subject cited above, I am directed to inform that considering the latest information on record, 76<sup>th</sup> Central Council of the PCI in its meeting held on 20<sup>th</sup> & 21<sup>st</sup> January, 2006 has decided to -

- grant approval for 2004-2005 & 2005-2006 academic session for 60 admissions for the conduct of Ist & IInd year B.Pharm course.
- allow 60 admissions in 2005-2006 academic session.

It was further decided to clarify the institution that M.Sc. is not qualified to teach under Education Regulations, 1991.

It was also decided to instruct the institution -

- that every year it has to apply to PCI in the SIF for the conduct of early inspection for year-wise approval or rejection of approval on the basis of which the institution can make further admission/no admission. When the students are in the final year B.Pharm an inspection will be conducted by PCI for consideration of approval of B.Pharm course u/s 12 of the Pharmacy Act for the purpose of registration as pharmacist. It is the responsibility of the Institution to apply in the prescribed SIF to PCI before 15<sup>th</sup> September every year alongwith complete documents.
- to comply with the requirements of Education Regulations, 1991 particularly regarding appointment of teaching staff and equipments.

This is for your information and submission of compliance with documentary evidence so as to reach the Council's office within 15 days of issuance of this letter.

Further, please find enclosed herewith a blank Standard Inspection Form for submission in triplicate immediately.
