Sir/Madam

With reference to the subject cited above, I am directed to inform that considering the latest information on record, 77th Central Council of the PCI in its meeting held on 17th & 18th August, 2006 has decided to –

- i) grant approval for 2006-2007 and 2007-2008 academic session for 60 admissions for the conduct of IIIrd & IVth year B.Pharm course.
- ii) allow 60 admissions for 2006-2007 academic session.

It was further decided to instruct the institution –

- i) that every year it has to apply to PCI in the SIF for the conduct of early inspection for year-wise approval or rejection of approval on the basis of which the institution can make further admission/no admission. When the students are in the final year B.Pharm an inspection will be conducted by PCI for consideration of approval of B.Pharm course u/s 12 of the Pharmacy Act for the purpose of registration as pharmacist and institution shall intimate the date of final year examination.
- ii) to comply with the requirements of Education Regulations, 1991 particularly regarding appointment of teaching staff and equipments.

It was also decided to approve the change in the name of the institution as per the following details subject to approval of State Govt.-
